Release of Liability Agreement

By signing this agreement I understand and agree to the following:

- I, for myself, my heirs, successors or assigns, hereby indemnify, release and hold harmless Milestone Church, its agents, servants and employees from any and all claims, demands, and causes of action or damages which may happen during my volunteering at Milestone Church. I therefore assume any and all risks attendant to volunteering with Milestone Church.
- Any reports, studies, tests, manuals, instructions, photographs, negatives, blue prints, plans, maps, data system
 designs, computer code, or any other documents or drawings prepared or in the course of preparation by me,
 shall be the exclusive property of Milestone Church, and all such materials will be remitted to Milestone Church by
 me upon the completion, termination or cancellation of my volunteer services. I agree not to use any such
